- I declare that during the event my exhibit will be covered by the minimum insurance requirements of the Road Traffic Act, be covered by a Boiler Insurance and by a Boiler Explosion Policy. Both policies must have a limit of indemnity of not less than €2,500,000 in any one accident and Sparks and Ashes cover of not less than €125,000.
- I further declare that the boiler of any steam plant entered carries a current Boiler Inspection Certificate and that I will produce a documentary evidence of such Insurance and Inspection to you before participating in the event. I further declare that each driver holds a driving license of the appropriate class and that they have read the NTET Code of Practice.
- I agree to produce, on request, an inspection certificate in accordance with the IEE regulations for any electrical equipment (i.e. generators, wiring, appliances).
- I agree to abide by the Code of Practice of the National Traction Engine Trust and the Society's written Statement of Safety Policy.
- I agree to operate my exhibit during the Event and to comply with the instructions of the Stewards.
